Agreement for optional medical services (status 22.09.2026) between the University Hospital Ulm (hospital) and the above-mentioned patient

about the provision of optional medical services that will be invoiced separately. This affects the **medical services** to all employed or civil servant hospital physicians who are involved in the treatment, if they are entitled to invoice their services separately within the scope of an inpatient, daycare and one-daycare (§ 115f SGB V) as well as preadmission and postdischarge treatments (§ 115a of SGB V), including services arranged by these physicians from physicians and institutions under medical direction outside the hospital § 16 BPfIV, § 17 Abs. 3 KHEntgG (private medical practitioner chain). The agreement equally applies for private medical services which are not liquidated by the private medical practitioner himself but the hospital.

Notes:

1. The **optional services agreement** comprises the **entire case of treatment**, even if it should be interrupted.
2. The optional services agreed on between the hospital and the patient that are to be separately invoiced, are **rendered within the scope of personnel and actual capabilities of the hospital** to the extent the general hospital services are not affected by this.
3. With regard to **deliveries**, claim against optional medical services by the mother **does not extend to the newborn. A separate optional services agreement** for the newborn is required.
4. The hospital can **refuse** to conclude an optional medical services agreement for patients who have **not paid** the **costs** of a previous hospital treatment or who have paid belated despite being due.
5. The hospital can immediately stop providing optional medical services temporarily, if and until this becomes necessary for rendering general hospital services to other patients. Otherwise, the **agreement** can be **terminated in writing** by the patient every day for the end of the following day. For an important reason, the agreement can be terminated by both parties without complying with a timeline.
6. If optional medical services have been agreed, the hospital can request **appropriate advance payments** as well as **appropriate instalments**.
7. If the **optional medical service "medical services" are claimed**, the selection **cannot be limited to individual hospital physicians who are entitled to authorise invoices to health insurances in their own name** (§ 17 Abs. 3 KHEntgG). An agreement on optional medical services comprises **all employed and civil servant hospital physicians** if they are entitled to invoice their services separately within the scope of an inpatient and daycare as well as preadmission and postdischarge treatments (§ 115a of SGB V), including services arranged by these physicians from physicians and institutions under medical direction outside the hospital. Within the scope of private medical treatments non-physician healthcare professionals can act at the instigation of physicians. As amended the liquidation takes place according to GOÄ/GOZ.

8. The **services that are invoiced separately**, even if they are charged by the hospital, are **provided personally** by the elective physician of the speciality department **or the institution under medical direction or under the supervision of the elective physician according to professional instructions by a subordinate physician of the department** or the institution (§ 4 Abs. 2 S. 1 GOÄ/GOZ) or by the permanent medical representative (§ 4 Abs. 2 S. 3 GOÄ/GOZ).

In case of the unforeseen prevention of the elective physician of the relevant speciality department, I agree that his tasks are taken over by his below designated permanent medical representative according to the following list:

There is no statutory health insurance coverage for claiming the above-mentioned optional services. If the optional services are claimed, the patient as **self-payer is obligated to pay the fee. Please review** if your private health insurance/subsidy or your legal health insurance company covers these costs over a special elective rate according to § 53 SGB V.

Agreement for optional medical services (status 22.09.2026) between the University Hospital Ulm (hospital) and the above-mentioned patient

about the provision of optional medical services that will be invoiced separately. This affects the **medical services** to all employed or civil servant hospital physicians who are involved in the treatment, if they are entitled to invoice their services separately within the scope of an inpatient, daycare and one-daycare (§ 115f SGB V) as well as preadmission and postdischarge treatments (§ 115a of SGB V), including services arranged by these physicians from physicians and institutions under medical direction outside the hospital § 16 BPfIV, § 17 Abs. 3 KHEntgG (private medical practitioner chain). The agreement equally applies for private medical services which are not liquidated by the private medical practitioner himself but the hospital.

Notes:

1. The **optional services agreement** comprises the **entire case of treatment**, even if it should be interrupted.
2. The optional services agreed on between the hospital and the patient that are to be separately invoiced, are **rendered within the scope of personnel and actual capabilities of the hospital** to the extent the general hospital services are not affected by this.
3. With regard to **deliveries**, claim against optional medical services by the mother **does not extend to the newborn. A separate optional services agreement** for the newborn is required.
4. The hospital can **refuse** to conclude an optional medical services agreement for patients who have **not paid** the **costs** of a previous hospital treatment or who have paid belated despite being due.
5. The hospital can immediately stop providing optional medical services temporarily, if and until this becomes necessary for rendering general hospital services to other patients. Otherwise, the **agreement** can be **terminated in writing** by the patient every day for the end of the following day. For an important reason, the agreement can be terminated by both parties without complying with a timeline.
6. If optional medical services have been agreed, the hospital can request **appropriate advance payments** as well as **appropriate instalments**.
7. If the **optional medical service "medical services" are claimed**, the selection **cannot be limited to individual hospital physicians who are entitled to authorise invoices to health insurances in their own name** (§ 17 Abs. 3 KHEntgG). An agreement on optional medical services comprises **all employed and civil servant hospital physicians** if they are entitled to invoice their services separately within the scope of an inpatient and daycare as well as preadmission and postdischarge treatments (§ 115a of SGB V), including services arranged by these physicians from physicians and institutions under medical direction outside the hospital. Within the scope of private medical treatments non-physician healthcare professionals can act at the instigation of physicians. As amended the liquidation takes place according to GOÄ/GOZ.

The **services that are invoiced separately**, even if they are charged by the hospital, are **provided personally** by the elective physician of the speciality department **or the institution under medical direction or under the supervision of the elective physician according to professional instructions by a subordinate physician of the department** or the institution (§ 4 Abs. 2 S. 1 GOÄ/GOZ) or by the permanent medical representative (§ 4 Abs. 2 S. 3 GOÄ/GOZ).

In case of the unforeseen prevention of the elective physician of the relevant speciality department, I agree that his tasks are taken over by his below designated permanent medical representative according to the following list:

There is no statutory health insurance coverage for claiming the above-mentioned optional services. If the optional services are claimed, the patient as **self-payer is obligated to pay the fee. Please review** if your private health insurance/subsidy or your legal health insurance company covers these costs over a special elective rate according to § 53 SGB V.
